INVESTMENTS IN EDUCATION

By championing programs that enhance early childhood development, support academic achievement and promote career readiness, UWRC aims to empower individuals to thrive academically and professionally. Through strategic partnerships and targeted investments, we are committed to building a brighter future where every learner can reach their full potential.



Big Brothers Big Sisters

United Way of Reno County supports the One-to-One Mentoring program, which served 76 youth in Reno County last year.



Boys and Girls Club

United Way of Reno County funds the Boys and Girls Club programming, which is designed with Academic Success, Good Character & Citizenship and Healthy Lifestyle Outcomes in mind. Last year, BGC Hutchinson served 1,438 youth in Reno County.



Boy Scouts of America Quivira Council

United Way supports youth engagement and community impact projects with the Boy Scouts Quivira council, impacting 126 youth last year.



Child Care Links

United Way of Reno County helps fund scholarships to cover the cost of daycare for families facing financial challenges. Last year, Child Care Links provided scholarships to 23 families.



Early Education Center

United Way of Reno County allocates funds to the Infant and Toddler program which is aimed at helping infants and toddlers in Reno County with special needs or who are at risk for developmental delays. Last year, the program served 1,009 children.



Girl Scouts of Kansas Heartland

United Way supported financial assistance, program opportunities and support services for 226 girl members last year in Reno County.



Hadley Day Care

United Way of Reno County supports childcare at Hadley Day Care, offering services to families of all income levels with a sliding-scale based tuition. Last year, they served 150 children and their families.



Hutchinson Public Schools Childcare Center

United Way of Reno County supports the USD 308 Childcare Center, which serves infants and toddlers in Reno County. Last year, they cared for 37 children.

Dolly Parton Imagination Library

United Way funds support the Dolly Parton Imagination Library program, which provides free, high quality, age-appropriate books to any child age 0 to 5 living in Reno County every month. Last year, 2,846 local children received books from the Imagination Library.

EMPOWERING EDUCATION: GRANT ADMINISTRATION

\$922,906 Early Childhood Block Grant

UWRC received a FY25 grant to enhance early childhood services for at-risk children from birth to kindergarten in Reno County schools, childcare centers, and family support agencies. The grant fosters a public/private partnership for high-quality, accessible, affordable programs.

\$1,500,000 of \$6M ARPA Childcare Grant in partnership with the Reno County Childcare Task Force

The Childcare Task Force has been guiding the utilization of ARPA Childcare funds and UWRC is the fiscal agent for distributing funds in the community. In 2024–2025, a projected \$1.5M - \$2.5M in grants will be distributed to address childcare needs in our Reno County community.

INVESTMENTS IN HEALTH

In our commitment to focus on the health of our community, UWRC is steadfast in promoting access to essential healthcare services, mental wellness supports and initiatives that foster overall well-being. By partnering with healthcare providers, community organizations, and advocates, we strive to address healthcare disparities, enhance preventive care and improve health outcomes for individuals and families across our region.



BrightHouse

United Way provides support for Advocacy and Shelter Services, the Parenting Time Center and Community Awareness initiatives. Last year, the Shelter served 555 individuals and provided Parenting Time Services to 275 people. BrightHouse also provided education to 1,734 people in our community about domestic violence.



Cerebral Palsy Research Foundation

United Way provides funding for the CPRF Wheelchair Clinic & Equipment Fund. Last year, this organization helped 60 individuals in Reno County by providing custom wheelchair systems or assisting with medical equipment.

Horizons Mental Health Center

United Way of Reno County supports Child Advocacy and Prevention Services at Horizons. Last year, 1,103 individuals were served through Prevention services and 300 individuals were served through intervention services. Additionally, UWRC supported Community Training and Education efforts. Horizons was able to reach 4,461 people through training efforts last year.



HOSPICE & HOMECARE
OF RENO COUNTY

Hospice and Homecare of Reno County

United Way of Reno County funds the Hospice House and the Children's Bereavement program. Last year, the Hospice House provided end-of-life care to 218 individuals at a reduced cost. This organization also supported 41 children that lost a loved one through their summertime "Space to Grieve" camp.



Hutchinson YMCA

United Way provides funds for Membership Financial Assistance and Will Power Hour. Through the Financial Assistance Program, the YMCA was able to help 500 people receive partial funding for their membership. Last year and 40 people benefitted from the FREE Will Power Hour.

Kansas Children's Service League

United Way supports the Healthy Families initiative, a program focused on the prevention of child abuse and neglect. Last year, the program served 123 family members in Reno County.



Hutchinson Meals on Wheels

United Way funds the Meals on Wheels program, which provides hot, nutritious meals 5 days a week to individuals that are unable to prepare their own meals, including elderly, disabled, and homebound community members. Last year, the program served 250 people.



Rise Up Reno Prevention Network

United Way provides support for the Drug Prevention program and the Reno County Suicide Prevention Coalition. RUR uses local trends and evidence-based programs to structure a comprehensive education and awareness effort that targets not only students but their parents too. Outcomes have shown decline in drug and alcohol use among youth in the last 3 years.

SingleCare

United Way's SingleCare Discount Prescription Drug program is a lifeline for many in our community, ensuring individuals can afford the medication they need. Last year, Reno County residents saved \$18,332 on medication costs using SingleCare.



The Delta Dental Program, a partnership between Delta Dental of Kansas and UWRC, provides dental benefits to those lacking access to quality care. Last year, 47 local residents received discounted dental care through this program.



United Way now offers a FREE, 24/7 mental and emotional support tool. Residents can chat with trained volunteers and access self-help guides and advice to improve their well-being.

United Way is committed to empowering individuals and families through programs that promote economic independence. By collaborating with local partners and stakeholders, UWRC provides access to essential resources, financial education, and workforce development opportunities. Through strategic investments, we work hard every day to create pathways to economic stability for all members of our community.



Circles Reno County

United Way supports the the Circles Reno County program, which connects people in supportive mentoring relationships across income levels. This program helps people who are economically vulnerable develop clear goals and specific plans in order to impact their future story. Last year, the program served 28 individuals and their families.



INTERFAITH HOUSING &
COMMUNITY SERVICES, INC.

Interfaith Housing and Community Services

United Way funds the Lighthouse, a program that houses and provides numerous supports to 18–25 year-olds experiencing housing insecurities. Last year, the Lighthouse served 13 young adults. UWRC also supports the Take Control Program, which helps families and individuals grow their financial wellness. This program helped 192 people last year. The Kansas IDA Program and the Home Repair and Rehabilitation Program at Interfaith are the final programs backed by UWRC, helping individuals to purchase a home as well as address home repairs for low-income and elderly persons. These programs served 27 and 162 people, respectively.



Kansas Legal Services

United Way supports the work of Kansas Legal Services, which is the sole poverty law firm in Kansas. Last year, they served 99 individuals in Reno County, which included help with immediate, intermediate, and long-term counsel on cases ranging from domestic violence situations to landlord-tenant conflicts.



New Beginnings Inc.

United Way provides support for NOEL Lodge Emergency Shelter, which offers emergency shelter to individuals and families who are homeless. The NOEL Lodge offers all clients dinner, laundry facilities, bathroom and shower amenities, breakfast and job search/internet access in a safe environment. Last year, the shelter served 308 individuals.



The Salvation Army

United Way supports the Emergency Assistance Program, which aids residents of Reno County who are facing momentary crisis situations cover living costs. Last year, the program helped 5,869 individuals.



The Volunteer Center of Reno County

United Way provides funding for the Volunteer Center volunteer program, Friends in Action Companionship and Shopping programs and the Volunteer Income Tax Assistance program—providing free tax preparation for low to moderate income households. Last year, 1,022 individuals volunteered in Reno County in some capacity, 44 Reno County residents were served through the Friends in Action efforts as well as 1,562 individuals were helped with tax preparation—resulting in more than a \$1M federal refund dollars coming back to Reno County.

FINANCIAL STABILITY INITIATIVES: UNITED WAY PROGRAMS IN ACTION



Reno Connections is a comprehensive case management program that aims to empower families to achieve their goals, not only to maintain stability but to work towards thriving. In 2023, 122 clients were able to be connected to 689 local resources, helping them on needs from obtaining IDs to safe housing and more.

My name is Heather Hutchinson, and I have a pride that swells every time I say, "My son, Oliver, attends Hadley Day Care Center." Our journey to Hadley was one filled with hope, luck, and the comforting knowledge that we found a place where Oliver could thrive.

Before Hadley, Oliver was in a home-based daycare that we adored. When Beth, our beloved daycare provider, decided to retire, we were heartbroken. The search for a new place was daunting, but Hadley kept appearing with glowing recommendations. We knew securing a spot at Hadley was rare, but luck was on our side—Oliver was ready to start, having conquered potty training just in time.

Since joining Hadley last year, Oliver has blossomed in ways that make a parent's heart swell with pride. He's not just learning colors; he's mastered them all. He's writing his name and other letters—there were tears when he wrote an 'H' and connected it to my name. He can count to twenty. These milestones are wonderful, but what truly matters are the life skills he's gaining—sharing, waiting his turn, social intelligence, and communication. These are the foundations that will shape his future.

For me, the decision to keep Oliver at Hadley instead of opting for a traditional preschool was surprisingly easy. The consistency and the steadfast care he receives make all the difference. As a working mom, knowing that the people nurturing my child are not just good but the absolute best is priceless. At Hadley, I drop Oliver off in the morning with the assurance that he will be happy, healthy, and safe until I pick him up.

Children spend a significant portion of their time with caregivers and educators, especially when parents work. The impact of these early years on a child's development cannot be overstated. At Hadley Day Care Center, Oliver is not just learning; he's thriving in an environment where love, care, and education go hand in hand.

As we look ahead, I am filled with gratitude for the role Hadley plays in Oliver's life and our family's journey. I know that with every day spent at Hadley, Oliver is building a strong foundation for a bright future.



BUILDING A BRIGHTER FUTURE

Diane's journey with Reno Connections



Diane's life took a pivotal turn thanks to the dedicated efforts of Kelsey Davies and the Reno Connections program operated by United Way of Reno County.

Diane had faced a lifetime of hardship, grappling with chronic homelessness and disabilities. Her situation seemed dire when she found herself at Noel Lodge, where she had stayed for over 110 days without making meaningful progress. The staff, implementing a new policy to prioritize improvement among long-term guests, referred her to Kelsey, the Community Care Coordinator at Reno Connections.

Kelsey immediately began working with Diane, understanding the complexity of her needs. One of the first steps was assisting Diane in applying for disability and Supplemental Security Income (SSI). Despite the challenges, several months later, Diane received approval, marking a significant milestone towards stability.

With Kelsey's guidance, Diane moved into transitional housing at Fox Run, where she not only found a safe haven but also began receiving essential financial counseling. Recognizing the multifaceted nature of Diane's needs, Kelsey connected Diane to additional resources such as a clothing voucher, updated glasses and a new prescription, ongoing disability support through Beyond Barriers, and crucial insurance coverage.

The impact of these interventions was significant. Diane now had a stable income and was actively engaged in skill-building activities. Her journey towards permanent housing was becoming a reality, with a projected timeline of the next year or two. Throughout this transformative process, Diane continued to meet with Kelsey biweekly for check-ins, providing crucial support and monitoring her progress.

Today, Diane's story stands as a testament to the power of community and dedicated support systems like Reno Connections. Through compassionate intervention and comprehensive assistance, Diane not only found stability but also regained hope for a brighter future.

FROM STRUGGLE TO SUCCESS

The Journey of Shawn and Lesley Stunkel with Circles Reno County.



In the heart of our community, stories of resilience and transformation unfold every day. When Shawn and Lesley Stunkel first joined Circles, they faced significant challenges. Despite being employed, they struggled to make ends meet for their family of four. Their living conditions were dire—a cramped 1-bedroom, 1-bath home with a landlord who neglected necessary repairs. It was a daily struggle against adversity.

However, Circles became a turning point in their lives. Through Circle Leader training, both Shawn and Lesley acquired essential financial and life skills. They learned how to navigate their circumstances with guidance and determination. But perhaps the most impactful aspect of their journey was their match with Terri, an HCC math instructor, and Mike, a seasoned professional with expertise in business and budgeting.

Terri and Mike's mentorship provided Shawn and Lesley not only with tools but also with invaluable connections within the community. With their guidance, Shawn improved his career pathway, opening up new opportunities for stability and growth. Meanwhile, Lesley pursued her dreams, currently on track to complete her Associate Degree in Early Education at HCC this spring—an achievement that speaks volumes about her determination and commitment.

Shawn and Lesley didn't just benefit from their match; they also became champions within the Circles community. Drawing from their own experiences of living in substandard housing, they actively participated in Big View discussions, sharing insights and advocating for change. Their journey from struggling participants to confident Circle Leaders exemplifies the life-changing power of the Circles model.

Today, despite facing ongoing challenges, Shawn and Lesley's family is not just surviving but thriving. Their story is a testament to the impact of supportive relationships and the strength of community. In the coming year, we look forward to continuing to support individuals and families like Shawn and Lesley's through Circles of Hope, fostering resilience, empowerment, and lasting change. Together, we can create a community where everyone has the opportunity to thrive.

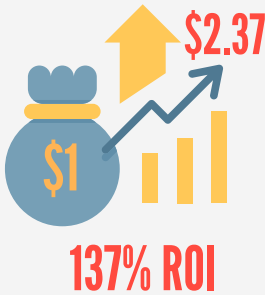
